WHO Welcomes UN Declaration on Universal Health Coverage

"This Declaration Represents a Landmark for Global Health and Development" Dr. Tedros Adhanom Ghebreyesus, Director-General-WHO

Geneva: World leaders adopted a high-level United Nations Political Declaration on universal health coverage (UHC), the most comprehensive set of health commitments ever adopted at this level.

"This declaration represents a landmark for global health and development," said Dr. Tedros Adhanom Ghebreyesus, Director-General at the WHO.

"The world has 11 years left to make good on its sustainable development goals. "Universal health coverage is a key to ensuring that happens.'

He added: "Universal health coverage is a political choice today; world leaders have signaled their readiness to make that choice. I congratulate

"The declaration comes the day after the World Health Organization

(WHO) and partners flagged the need to double health coverage between now and 2030 or leave up to 5 billion people unable to access health care.

In adopting the declaration, UN Member States committed to advance towards UHC by investing in four major areas around primary health care.

These include mechanisms to ensure no one suffers financial hardship because they have had to pay for healthcare out of their own pockets and to implement high-impact health interventions to combat diseases and protect women's and children's

Additionally, countries must strengthen the health workforce and infrastructure and reinforce governance capacity. They would report back on their progress to the UN General Assembly in 2023. "Now that the world has committed to health for all, it is time to get down to the hard work of turning those commitments into results," said Melinda Gates, Co-Chair of the Bill & Melinda Gates Foundation.

"We all have a role to play. Donors and country governments need to move beyond business as usual to bolster the primary health care systems that address the vast majority of people's needs over their lifetimes," said Gates.

The WHO and 11 other multilateral organizations, which collectively channel one-third of development assistance for health, launched their Global Action Plan for health and wellbeing for all.

The plan ensured the 12 partners provide more streamlined support to countries to help deliver universal health coverage and achieve the health-related SDG targets.

The Regional and District Health Authorities Act, 2019 passed by the KPK Assembly The Federal and Provincial Governments Provide Funds to Each Authority, Authorities will Report to a Policy Board, Chaired by the KP Health Minister

Peshawar: The federal and provincial government will provide funds to each authority that will report to a policy board, chaired by the KP health minister. The regional authorities will have the power to:

- Ensure that objectives set by Regional Health Authority (RHA) are achieved and oversee effective management and issue strategic directions to health facilities in the assigned region.
- Approve budget of RHA and allocate funds to health facilities
- · Oversee health service delivery
- Implement government policies and directions
- Ensure that its programs are effective and efficient
- Ensure transparency

The law also dictates that the doctors that are already serving, will continue to be treated as civil servants and will be entitled to pension and other such benefits. The regional health authority will have the authority to transfer doctors as per need in health facilities in their respective districts of domicile.

The law further says that the existing cadre will be treated as the "dying cadre" and will continue until the retirement of the last civil servant, after which the posts will be abolished and regional authorities will have the power to create positions and recruit as per regulations.

At least 10 medical professionals suffered injuries after Peshawar police resorted to tear gas shelling and launched a baton charge in the premises of the Lady Reading Hospital (LRH) in order to disperse doctors who had gathered there to protest. Among the injured was Young Doctors Association (YDA) Chairman Dr Zubair, who is reportedly in critical condition, the association's spokesperson Dr Izhar said, YDA President Dr Rizwan Kundi's am was also allegedly fractured after police used force to stop the demonstration.

More than 15 protesters had been arrested, including paramedies and female nurses, the spokesperson claimed. Talking to media about the clashes, Senior Superintendent of Police (Operations) Zahoor Babar Afridi said that the police had resorted to force in a bid to control the situation. He said that about eight police officers had been injured by stone pelting by doctors and 13 protesters were detained.

Doctors across Khyber Pakhtunkhwa have been protesting for the past two days against the Regional and District Health Authorities Act, 2019 which was passed by the provincial assembly today — which they describe as "nothing short of privatization of government hospitals". They had announced to gather in Peshawar to protest against the law.

Following the announcement, the district administration had imposed Article 144 in the LRH premises on the request of the hospital's administration, forbidding more than five doctors from gathering in one place. The administration of the hospital had also advised doctors to carry their hospital identity earls with carry their hospital identity cards with them at all times as they were not to be allowed to enter the hospital premises without them

The hospital spokesperson had also announced that the administration will not allow anyone to protest and strict action would be taken against those who disobeyed orders. Heavy contingents of police were also deployed outside LRH. After the clashes, the protesters staged a sit-in on GT Road, near the KP Assembly. According to the doctors, they had not been consulted by authorities in the drafting of the bill.





Govt Committed to Ensure Universal Health Coverage:Dr. Zafar Mirza
Prime Minister Imran Khan was
very much Supportive of the Efforts to Elaborate the
Global Burden Disease estimates in Pakistan

Islamabad: Special Assistant to the Prime Minister on National Health Services, Regulations and Coordination Dr Zafar Mirza said universal health coverage was the top priority of the government.

Addressing the inaugural session of the five-day national workshop on 'global burden of the disease studies of Pakistan', he said Prime Minister Imran Khan was very much supportive of the efforts to elaborate the Global Burden Disease estimates in Pakistan, specially to have the actual data for the disease patterns to provide universal health services to the people of Pakistan.

Dr Zafar Mirza informed that the ministry was currently developing a National Essential Package of Health Services (EPHS) and inter-sectoral policies based on Disease Control Priority-3, including the best global practices, to make essential services available at five different levels of health care services to facilitate the underprivileged and provide more equitable health services.

He emphasized that the Global Burden of Disease studies would help the policy makers to get the exact estimates of the disease burden of the country which would be adopted for the development of a comprehensive EPHS to be implemented at all levels of healthcare delivery system.

He emphasized upon the importance

of sub-national burden of the disease studies and suggested that the burden of disease data should be collected until the union council level to have an accurate decentralized picture of the disease patterns of the country and each and every administrative segment of the country including union councils, tehsil, districts and provinces.

Dr Zafar Mirza informed that the ministry has initiated dialogue with Institute for Health Metrics and Evaluation (IHME) for facilitation and support to develop Burden of Disease Estimates for Pakistan for the year 2017 and onwards and for the development of Central Data repository in context of relevant priority areas like communicable diseases, non-communicable diseases, RMNCAH/Nutrition and Health system that would be integrated in National dashboard.

The workshop was organized to start formal deliberations on the GBD studies in Pakistan. The workshop is being conducted under the guidance of Ali H. Mokdad, PhD, Professor of Health Metrics Sciences at the Institute for Health Metrics and Evaluation (IHME) and Chief Strategy Officer for Population Health at the University of Washington.

The workshop was attended by the representatives of Provincial Departments of Health, academicians, clinicians, researchers and other stakeholders.

Heartburn Medicine Ranitidine Recalled in Pakistan Over Cancer Concerns Food and Drug Administration in US had Issued Warning of Drug Containing Carcinogen Ingredients in Ranitidine Canada, France and Other Countries have Already Suspended Selling of Drug

New York, USA: Pharmacy chains in the United States have suspended the sale of heartburn medication Zantac after the Food and Drug Administration (FDA) issued a warning that the drug contained potentially cancer-causing ingredients.

The pharmacy chains Walgreens, Rite Aid and CVS have announced that they are no longer selling Ranitdine products. Rite Aid is in the process of removing Ranitidine and generic versions sold under the Rite Aid name from its shelves, a Rite Aid spokesman told New York Times. Since the alert by FDA, Canada, France and other countries have removed the drugs from pharmacy shelves. Bangladesh also issued a temporary ban on the import, production and sale of ranitidine.

DRAP engages International bodies for further probe after medicine recall over cancer fears

Ranitidine is a medication that works to lower the acid created in the stomach. The drug is also prescribed to prevent ulcers of the stomach and intestines as well as gastroesophageal reflux disease.

Last month, the FDA issued a statement alerting patients and health care professionals of N-nitrosodimethylamine (NDMA) found in samples of ranitidine. "The U.S. FDA has learned that some

nitidine medicines, including some boducts commonly known as the and-name drug Zantac, contain a ranitidine, the

ranitidine medicines, including some products commonly known as the brand-name drug Zantac, contain a nitrosamine impurity called N-nitrosodimethylamine (NDMA) at low levels," the statement said.

NDMA is classified as a probable human carcinogen which is a substance that could cause cancer on the basis of animal studies. It is known environmental contaminant and found in water and foods, including meats, dairy products and vegetables.


Islamabad: Heartburn medicine Rantitidine being recalled in Pakistan over cancer concerns Rantitidine, a heartburn medicine that the FDA said contains a cancer-causing chemical, has been banned across Pakistan. The Drug Regulatory Authority of Pakistan has stopped pharmaceutical companies from producing and selling Rantitidine said its head Dr Asim Rauf.

He added that DRAP was working


with international bodies to improve the monitoring and evaluation of ranitidine, the chemical name for Ranitidine. The regulatory authority had begun investigating ranitidine after the US Food and Drug Administration announced that it contained traces of cancer-causing contaminant NMDA, said Dr Rauf. The American drug regulator had warned patients that ranitidine had been found to contain "low levels" of the cancer-causing impurity N-nitrosodimethylamine or NDMA.

"NDMA is a known environmental contaminant and is found in water and foods, including meats, dairy products, and vegetables," the FDA added.

The patients have been advised to consult their doctors for medicine's alternatives. Recently, pharmaceutical retailers across the US have stopped marketing and selling Ramitidine products. Canada and France have issued total recalls of the drug.


